## Section 1 Introduction

Unlike many other Awarding Organisations, FDQ does not charge an Annual Fee to our centres.

However, for the term beginning 1 September 2023 to 31 August 2024 FDQ are raising the annual Minimum Registration Spend (MRS) threshold to £1,000.

### Minimum Registration Spend

FDQ's Fees and invoicing policy sets out how we charge centres for our products and services. The Policy includes a Minimum Registration Spend (MRS) Threshold Statement. FDQ requires that centres meet the threshold with their annual spend on learner registrations.

### FDQ's Annual fees period

All fees detailed in this Guide apply from 1 September 2023 to 31 August 2024.

FDQ reserves the right to review and revise its fees in this period. We may need to re-issue this Guide to incorporate newly accredited qualifications and products. In cases of change, FDQ will update and re-issue this Guide to centres via the Main Centre Contact. We will also notify centres in the FDQ Newsletter.

The fee also includes:</p> <ul style="list-style-type: none"><li>• remote approval support</li><li>• additional flexible business support</li><li>• annual external quality assurance meeting (as required by the relevant compliance model)</li><li>• unlimited qualification review approval (for existing qualifications)</li><li>• online portal access</li><li>• FDQ branded wall plaque issued on approval (in first year only)</li></ul> <p>The centre approval fee also includes approval for up to six qualifications selected by the centre to include in their commencing portfolio. (The centre must meet FDQ's criteria for qualifications approvals for each qualification chosen).</p>

## Annual Minimum Registration Spend (MRS) threshold

MRS threshold		
<b>1.3</b>	Minimum Registration Spend (MRS) threshold  £1,000	<p>The MRS threshold is based on registrations made in the financial year (1 September to 31 August). A centre spending less than £1,000 in the year will be subject to the MRS threshold and will be invoiced for the difference between the actual spend and the MRS threshold on August 31st of the year.</p> <p>FDQ reserves the right to waive this minimum charge based on individual centre requirements.</p> <ul style="list-style-type: none"><li>• New centres are exempt from meeting the MSR threshold in the first year of their approval (i.e. from the date of approval to 31st August).</li><li>• Centres can pay for their own annual EQA visit and the £400 fee will contribute to their annual MRS.</li></ul>

## External Quality Assurance fees

MRS Annual External Quality Assurance (EQA) Visit		
<b>1.3</b>	£400	This fee applies only to lower volume centres that are close to or likely to spend less than the £1,000 MRS threshold in a year.
Additional EQA visits - approved centre		
<b>1.3.1</b>	Onsite £400	<p>All FDQ centres must receive at least one face to face EQA visit annually. FDQ does not charge for the one annual visit. The EQA activity confirms a centre's continued FDQ recognition and ability to register learners for qualifications and claim certificates to FDQ's required standards.</p> <p>However, FDQ can exercise its right to charge for additional EQA activities under the terms of the annual Centre Agreement.</p>

<b>1.3.3</b>	Full Day £200	Where EQA is required/requested by a centre, FDQ can charge an additional fee (full day or half day) depending on the sample size.

## Administration fees

Certificate replacement fee		
1.4	£25	The fee includes a search of our archive records, issue of a replacement certificate and delivery within the UK or Europe.

The following administrative charges are avoidable if centres use FDQ's systems accurately. However, FDQ does charge an administrative fee for work undertaken by FDQ staff

- to correct errors made by centres in registering or administering learner information
- when centres request FDQ undertake administrative work on their behalf which our systems enable centres to complete themselves.

## Definitions of qualification size

Some of FDQ's charges vary according to the size of the qualifications. For the purpose of this Fees Guide we use the following definitions of terms:

Term	Qualification type
Short	Qualifications typically taking less than a day or 12 Guided Learning Hours (GLH) to complete. Most of our Compliance and Knife Skills qualifications are short. For example <ul style="list-style-type: none"><li>• Level 2 Award in HACCP based Food Safety Systems</li><li>• Level 2 Award in Knife Skills for Food Processing</li></ul>
Medium	Qualifications typically taking less than 100 GLH to complete. For example <ul style="list-style-type: none"><li>• Level 2 Award in Protecting the Welfare of Animals at time of Killing</li></ul>
Long	Qualifications typically used as full /part time provision and take 350+ GLH to complete. Our Professional and Proficiency qualifications are long. For example <ul style="list-style-type: none"><li>• Level 2 Certificate for Proficiency in Meat &amp; Poultry Industry Skills</li><li>• Level 3 Diploma in Professional Bakery</li></ul>



Administration Fees		
1.5	£10 to £35 based on number of learners.	<b>Batch Error Fees</b> Administration fee of £10 per learner or £35 per cohort (of more than five learners) applies if FDQ are required to undertake extra administrative work to correct errors made in registration or administration of learners (e.g. removing/correcting names or adding/withdrawing units already applied for).
	£25	<b>System amendments</b> A fee of £25 per learner applies for any administrative requests that FDQ undertake on a centre's behalf which our systems enable centres to complete themselves. (e.g. selecting units or making name changes).

Transfer and Backfill Fees		
1.6	£20	<b>Transfers:</b> A fee applied If a learner is registered on a qualification and transferred to another. The learner will then appear in a new registration batch. The fee for this transaction is £20 for <b>medium to long qualifications</b> .
	£20	<b>Backfill:</b> A fee applied if a centre has withdrawn or transferred a learner. The space that is left on that original qualification, may be backfilled by another learner for a charge of £20. The backfill is usually made at the point of withdrawal/transfer. However, centres can replace or backfill the learner with a new learner within 12 months. The new learner will remain in the same batch.
	£6.50	<b>The fee for short qualification</b> backfills/transfers is £6.50.

1.7	£20	<b>Re-sit:</b> A fee applied If a learner fails an examination and wants to complete a second (or third) examination. There is a fee of £20 for each re-sit the learner completes.

Qualification Development Fee		
1.8	Typically between £1,000 and £5,000	FDQ can develop new qualifications that will be regulated.  Costs will be determined by several factors, such as the type and size of qualification requested, Regulatory requirements and the time required for development.

Endorsed Programme Development		
1.9	£1,000+ dependent	FDQ can provide development services for courses or programmes not in the regulated qualifications market. An endorsed programme affords an opportunity to develop and bespoke to your requirements with FDQ providing expertise to assist on content, assessment and certification.  Costs will be determined on several factors, such as the type and size of the qualification and the time required for development.

FDQ will however be able to recommend an independent consultant with expertise on IQA to provide a IQA advisory service.</p> <p>The Centre will be responsible for agreeing the programme with the consultant.</p> <p>For the avoidance of doubt, this is a strictly commercial and independent arrangement between the Consultant and centre to agree to the IQA/Assessment needs and settle on a suitable package of services and fees.</p>

1.11	£350	<p>Complaints are dealt with as per FDQ's Complaints policy and procedure. The complainant is charged for expenses incurred if an Independent Investigator (Stage 4) is needed. If the complaint is upheld the cost is refunded to the complainant.</p> <p>Appeals are dealt with as per FDQ's Appeals policy and procedure. The appellant is charged for expenses incurred in the operation of the Appeals Panel (Stage 4) if needed. If the appeal is upheld the cost is refunded to the appellant.</p>
