EPA FEES GUIDE

INTRODUCTION

FDQ is the only specialist End-point Assessment organisation (EPAO) serving the food and drink industry. FDQ's fees guide is intended to provide stakeholders with information on the costs and circumstances that apply for the provision and fee setting for all the EPAs that we are approved to deliver.

The Fees guide is a working document meaning it is subject to change throughout a calendar year as standards may change and/or as FDQ introduces new occupational EPAs.

FDQ AND OUR VALUES

FDQ is wholly owned by a Skills Charity (Food and Drink Training and Education Council) set up over 20 years ago to serve the food and drink industry with qualification and assessment services. To this end, FDQ is the only food specialist End Point Assessment Organisation (EPAO), and our primary aim is to provide the best quality assured end point assessment services at a fair and reasonable price.

INVOICING FOR EPA SERVICES

The fee for EPA is agreed at the earliest opportunity by an FDQ EPA Manager (EPAM) once the apprentice has reached gateway and the mode and personal circumstances have been discussed. When the EPA booking has been agreed FDQ will generate the invoice and a schedule for the agreed services.

This will be the price that has been agreed with the relevant EPAM and the centre. Invoices are required to be paid within 30 days of the invoice been issued.

PAYMENT METHODS

For FDQ Centres the usual BACs based payment system applies.

FEES STATEMENT

The fee's quoted in this guide are split for each standard showing.

First Attempt Fee

Based on an individual apprentice making their first attempt to complete the EPAs set out in the relevant standard. These are based on the most straightforward scenario and your EPAM will confirm the prices at the initial pre-EPA meeting as discounts can often apply. Prices may fluctuate from the catalogue price.

Resit/Retake Fee

2nd attempts will be confirmed by the relevant EPAM. Similar to 3rd and 4th attempts at the EPA. The final fee depends on a range of circumstances, not least any reasonable considerations to support apprentice's 2nd attempt to complete their EPA. Prices may fluctuate from the catalogue price to reflect for example where an online option may be available, this often applies for knowledge tests re-sits/takes which cost less than occasions where FDQ is required for an onsite EPA.

EXTRA INFORMATION

GUIDANCE FOR RE-SITS/RETAKES

Apprentices who fail one or more EPA components will be offered re-sits/re-takes. Re-sits/re-takes must not be offered to apprentices wishing to move from pass to any other grade. A re-sit does not require further learning, whereas a re-take does.

The apprentice's employer will need to agree that a re-sit/re-take is an appropriate course of action. Apprentices should have a supportive action plan to prepare for the re-sit/re-take.

Please see relevant Guides to EPA for information on resit/retake timelines ad our individual EPA fees for specific EPA re-sit/retake charges.

The fee that may apply for an online interview type of EPA resit can vary depending on the standard and in some cases the duration, in such cases our EMA Manager (EPAM) will be able to advise on the set fee.

REFUND OF FEES

If FDQ cancels an EPA, then any fees paid will be automatically refunded to the applicant organisation.

If the apprentice, training provider or employer cancels their EPA without providing two working days' notice to FDQ the fee remains payable in full as detailed in the EPA itineraries, any fees paid will not be refunded. This always applies and in all situations, including changes of circumstance and cases of hardship.

If the apprentice is not able to undertake their EPA on account of ill health, then, on the production of medical evidence (e.g. a doctor's note), a postponement may apply and the EPA could be rescheduled.

The FDQ Chief Executive must approve any refunds/credit notes before issue. In the absence of FDQ's Chief Executive, FDQ's Operations Manager will be able to approve any refunds/credit notes.
